**Preamble :**

Annal J.K.K. Sampoorani Ammal College of Education, T.N.Palayam, Gobi Taluk, Pin - 638506, Erode District, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for Secondary(B.Ed) Course.

Hon'ble High Court of Madras in W.P.17493 of 2005 has directed NCTE to cause inspection within a period of 3 months. Accordingly, an inspection was carried out on 23.11.2005. The inspection report was placed before 106<sup>th</sup> SRC meeting held during 15-16 December 2005.

After considering the application and other relevant materials furnished by the applicant institution, had noted that the applicant institution does not fulfill the requirements and issued a notice on 26.12.2005 to the applicant institution under provisio to Section 14(3)(b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

The written representation submitted by the said institution on 26.12.2005 was considered by the Regional Committee in its 107<sup>th</sup> meeting held on 27<sup>th</sup> December 2005 and decided to accord recognition.

Some of the institutions who have been granted recognition for the subsequent year have preferred appeal before NCTE, New Delhi to reconsider their cases of grant of recognition for the session 2005-06 itself instead of 2006-06. The NCTE, New Delhi vide order No.F.No.89-156/2005 Appeal dated.28.9.2005 has remanded back the case to SRC with a direction to reconsider these cases immediately for grant of recognition for the session 2005-06.

SRC in its 104<sup>th</sup> meeting held on 9-10 November, 2005 has considered the legal opinion obtained in this regard and has taken decision to grant recognition to the session 2005-06 to those institutions who have submitted belated NOCs/Endorsements and also the essential documents mentioned in Appendix-1B of NCTE Regulations as one time exception.

Hence the order.

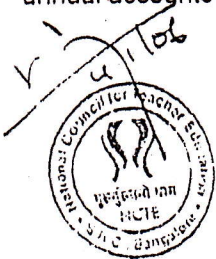
In terms of Section 14(1) of the NCTE Act, 1993 Annal J.K.K. Sampoorani Ammal College of Education, T.N.Palayam, Gobi Taluk, Pin - 638506, Erode District, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for Secondary(B.Ed) Course of one year duration from the academic session 2005-06 with an annual intake of 100 students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
- The institution has acquired the land for setting up the teacher education institution.
  - The institution has made arrangements for conducting the course in the own premises.
  - The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 3 lakhs.
  - The institution has selected the Principal and Seven lecturers for the said course.
3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **Annai J.K.K. Sampoorani Ammal College of Education, T.N.Palayam, Gobi Taluk, Pin - 638506, Erode District, Tamilnadu** for **Secondary(B.Ed)** course of one year duration from the academic session 2005-2006 with an annual intake of 100 students subject to fulfillment of the following.
- The institution will ensure that Principal and Seven faculty members duly approved by affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.
  - The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
  - The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
  - The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC, State Government etc.
5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

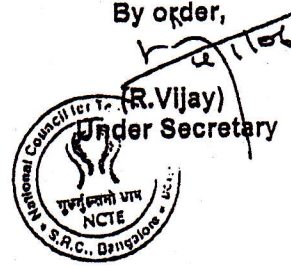

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.



**ORDER:-**

The Chairman and the Secretary, Annai J.K.K. Sampoorani Ammal Charitable Trust, Ethirmedi, Valayakaranur Post, Komarapalayam, Namakkal District has sent an application to the Southern Regional Committee for National Council for Teacher Education / State Government seeking, permission to the Educational Agency to start a self-financing College of Education in the name and style, "Annai J.K.K. Sampoorani Ammal College of Education", Punjai Thurayam Palayam Village, T.N. Palayam Post, Gobichettypalayam Taluk, Erode District during the year 2005-2006.

2. The Southern Regional Committee, National Council for Teacher Education, Bangalore has given recognition to start the above said College of Education during the year 2005-2006 with an intake of 100 students.

3. The Government, after the scrutiny of the application and examination of the report and the recommendations of the Director of Collegiate Education in the letter 4<sup>th</sup> read above and taking into account the recognition given by the National Council for Teacher Education in its letter 3<sup>rd</sup> read above, convey No-Objection to the Bharathiyar University, Coimbatore for consideration for grant of affiliation to "Annai J.K.K. Sampoorani Ammal College of Education", Punjai Thurayam Palayam Village, T.N. Palayam Post, Gobichettypalayam Taluk, Erode District to be started by "Annai J.K.K. Sampoorani Ammal Charitable Trust", Ethirmedi, Valayakaranur Post, Komarapalayam, Namakkal District on self financing basis, temporarily in the building in S.No. 395, Thokkanaickanpalayam Village, T.N. Palayam Post, Gobichettypalayam Taluk, Erode District and Permanently in Survey No. 395, Punjai Thurayam Palayam Village, T.N. Palayam Post, Gobichettypalayam Taluk, Erode District measuring an extent of 16.04 acres with the courses of Tamil, English, Physical Science, Biological Science, History, Mathematics, Economics, Commerce and Computer Science subjects with an intake of 100 Students in accordance with National Council for Teacher Education Acts and Rules / Regulations made thereunder, during the academic year 2005-2006.

4. The Educational Agency should fulfill the following conditions also:-

- i) The management should execute an agreement in stamp paper to abide by all conditions prescribed by the Government / National Council for Teacher Education.
- ii) The lands mentioned in para 3 above should not be utilized for any other purpose other than college purposes.
- iii) The Government will not grant any financial assistance at any time.



teaching and non teaching staff shall be appointed as per the yardstick prescribed by the National Council for Teacher Education/University Grants Commission and they should possess the qualifications prescribed by the respective University  
The management should not collect capitation fee or donation in any form other than the admissible fees as per the prescription of the Government from time to time

- vi) The management shall collect Tuition fees, Special Fees, Application fees, Registration fees, laboratory fees, Security deposit only as per the rates prescribed by the Director of Collegiate Education / Government.
- vii) The management should strictly follow the guidelines issued by the Director of Collegiate Education during admission time and should fill up 50% of the seats as well as additional seats by adhering to the reservations policy of the Government.
- viii) If the management creates a situation causing the closure of the college for any reason, the Government will not come forward to take over the college.
- ix) The management should strictly adhere to such other conditions prescribed by the National Council for Teacher Education / State Government / University.
- x) The Management should provide the fire prevention facilities and Rain Water Harvesting provision in the college buildings and also to obtain Electricity Board safety certificate
